The Institute provided new sheriffs' training, held a spring and fall conference for sheriffs and deputies and communicated to citizens of Virginia on issues relating to crime and justice. The Institute conducted lawful employment practices for law enforcement personnel training and a Fair Labor Standards Act training symposium for sheriffs and deputies.

The Institute provides a quarterly newsletter that goes to its members from the sheriffs that contains information on new Virginia laws, crime prevention topics, and training and education updates.

The Virginia Sheriff's' Scholarship program was established in 1981 to provide an opportunity for young people across Virginia to pursue an educational curriculum in criminal justice. Scholarships are provided to students throughout Virginia who major in criminal justice at a Virginia college or university. VSI awarded 111 scholarships for 2014-2015 to Virginia's youth.
