

Election Day Is Almost Here — Know Where the Candidates Stand on the Issues!

Elections for your State Delegate and Senator, who are responsible for decisions on funding law enforcement efforts in Virginia — as well the election for your local Sheriff — will take place on November 8, 2011. All 140 seats of the Virginia General Assembly are up for election this year.

As a Virginia resident, you need to know whether the candidates for Virginia's State Legislature are willing to support the work of your Sheriff to promote crime prevention in your community. So before you cast your vote, I encourage you to find out where your candidates stand on this and other important issues that may impact you and your family.

VSI is leading this vital effort to raise public awareness about the upcoming elections so citizens like you learn more about the candidates and get out and cast your vote on November 8th — either through absentee ballot or at the polls!



This is an important decision. So study the candidates' websites and contact them. Ask inquiring questions. Attend debates. Be informed and know your choices.

REVENUE FROM NEW VSI LICENSE PLATES TO SUPPORT DEPUTIES INJURED OR KILLED IN THE LINE OF DUTY

Show your support for law enforcement by displaying a specialized DMV license plate on your car. The proposed "I Support Sheriffs" theme and design has already received approval from our Board of Directors. But before DMV can develop and issue these specialized license plates, the General Assembly **now requires us to accumulate a minimum of 450 paid applications!** (See enclosed application)

VSI's Board of Directors met on July 12th and voted to promote the specialized VSI license plate, which is available to all Virginians. The \$25 annual fee for your specialized plate will go towards assisting Deputy Sheriffs that have been permanently and totally disabled in the line of duty; and will benefit the families of deputies killed in the line of duty, in an effort to relieve personal and community distress relating to such incidents. **To ensure this project moves forward, applications must be received by November 1st.**

On behalf of all of us at the Virginia Sheriffs' Institute, I want you to know how proud we are to represent your local Sheriff, Deputies, and residents, like you. You continue to be a most trusted

partner in our efforts to promote crime prevention in all across the Commonwealth.

And so to further support Virginia law enforcement, I hope you'll complete and return the enclosed application for your "I Support Sheriffs" specialized license plate, offered to Virginia citizens.
