VSI provided a lawful employment practices for law enforcement personnel program and an executive management training program. VSI sponsored many law enforcement related non-profits, including the National Law Enforcement Officers Memorial Fund. VSI provided reports and statistics to supporters regarding crime and criminal justice in Virginia through direct mail, email and on VSI's website.

The Institute provides a quarterly newsletter that goes to its members from the Sheriffs that contains information on new Virginia laws, crime prevention topics, and training and education updates.

The Virginia Sheriffs' Scholarship program was established in 1981 to provide an opportunity for young people across Virginia to pursue an educational curriculum in criminal justice. Scholarships are provided to students throughout Virginia who major in criminal justice at a Virginia college or university. VSI awarded 66 scholarships for 2021-22 to Virginia's youth.
