LEARN ABOUT NEW LAWS TAKING EFFECT

The Virginia Sheriffs' Institute (VSI) monitors all legislation that impacts the office of the sheriff. VSI would like to touch on a few key pieces of legislation regarding public safety taking effect in July:

- **SB186** (Farm placard bill) requires that farm placards be registered with DMV.
- **HB451** (Stalking bill) changes venue requirements, so that stalking can be prosecuted where the communication is received, even if sent from out of state.
- **SB36** puts back into place the requirement for school officials to report to law enforcement sexual assault and other crimes on school property.
- HB740 makes the tampering of a

vehicle for the purpose of taking a catalytic converter a felony.

- **HB632** allows law enforcement to stop and enforce vehicles with excessively loud exhaust.
- **SB758** (Switchblade bill) reverses a long-time ban on possession of a switchblade. The bill simply removes switchblades from a list of weapons Virginians are banned from possessing or selling.
- **SB777** ("Carolina Squat" truck bill) – bans modified "Carolina Squat" vehicles — which are any "passenger car or pickup or panel truck" that's been modified to raise the front bumper four inches or higher than the rear bumper — from Virginia roadways.

REPORT SHOWS 2021 ONE OF DEADLIEST YEARS FOR LAW ENFORCEMENT



According to preliminary data compiled by the National Law Enforcement Officers Memorial Fund (NLEOMF), as of December 31, 2021, 458 federal, state, tribal, and local law enforcement officers died in the line-of-duty in 2021. This is an increase of 55% from the 295 officers killed during the same period last year and is the highest total line-of-duty officer deaths since 1930 when there were 312 fatalities.

COVID-19-related fatalities accounted for the single highest cause of death among law enforcement officers. There were a reported 301 COVID-19-related deaths in 2021 at the time of the report's release.

The unofficial figure is projected to be much higher given that there are cases where it cannot be determined whether there was direct contact with a COVIDpositive individual while performing in their official capacity.

According to NLEOMF's report, trafficrelated deaths increased from 2020. Of particular concern were "struck-by incidents," which is when officers are hit by other vehicles while standing outside of their patrol vehicles, either investigating crashes or assisting motorists.

Firearms-related fatalities saw a spike last year. Law enforcement officers killed in ambush style related attacks in 2021 also increased.

Last year, there were seven law enforcement officers killed in the line of duty in Virginia.

NATIONAL TRAFFIC AWARENESS MONTH



August has been designated U.S. National Traffic Awareness Month. This is an opportunity for drivers to be aware of decisions they can make on the roads to ensure their safety and that of pedestrians and other drivers.

With the recent dramatic spike in pedestrian and vehicle-related deaths, August is an

important month for drivers and pedestrians to reflect on the importance of paying attention to the road and following all traffic rules. The best thing you can do to help ensure your safety and those around you is to be aware.

To stay safe in traffic, remember to: check your mirrors and blind spots, use your turn signal, avoid speeding, and leave adequate space between your vehicle and others.

2022 VSI CERTIFICATION CLASS

VSI congratulates the 2022 class of the VSI Certification Program. Certificates of completion were awarded at the spring conference. In addition, three members achieved recertification this year.

The Virginia Sheriffs' Institute offers the Certification Program to recognize the continued individual professional development of Virginia sheriffs and deputies. Certification through this voluntary program provides recognition of a sheriff or deputy's commitment to excellence, life-long learning, and advancement of public safety as a profession.

Sheriffs and deputies serving in Amherst County and throughout the Commonwealth of Virginia carry immense responsibilities as the guardians of their communities, providing effective public safety services balanced with the fair and equitable treatment of every individual they encounter.

IF YOU SEE AN UNATTENDED CHILD IN A HOT CAR

In 2015, Virginia passed a law that provides civil immunity for anyone who forcibly enters a vehicle to remove an unattended minor at risk of serious



bodily injury or death. The one caveat in the law is that **you must call 911** before breaking into the vehicle if it is feasible under the circumstances.

However, if you see an unattended animal in distress in a car, be aware that only law enforcement, firefighters, emergency medical services personnel and animal control officers are able to break into the car and not be held liable, and specifically, the law only protects unattended companion animals.

As a reminder, even with windows cracked, it only takes a few minutes for a car to heat up.

DON'T LET SCAMMERS TAKE ADVANTAGE OF YOU

This summer, scammers aren't taking a break. Any Virginian can fall victim to a scam. That is why we wanted to remind you about the several key steps you can take to protect yourself from scammers:

- It bears repeating: if the offer seems too good to be true, it probably is
- Never pay fees or taxes in advance for "winnings"
- A genuine business will never threaten or pressure you to act immediately
- If you can't find information about the person or business online, it is probably a scam
- Never hand out personal information or wire money to someone you don't know
- Be suspicious if the correspondence you receive is full of grammatical errors or poor production values
- If there is no physical address and your contacts won't give you one, then it's a scam
- Never give someone else remote access to your computer

NATIONAL NIGHT OUT

August 2, 2022 is National Night Out, a day meant to increase awareness about police programs in communities, such as drug prevention, town watch, neighborhood watch, and other anticrime efforts.

According to the National Night Out's official website, "millions of neighbors take part in National Night Out across thousands of communities from all fifty states, U.S. territories and military bases.

No sheriff's office can operate effectively without the support and cooperation of the people it serves. That is why I am so grateful for your continued support of the Virginia Sheriffs' Institute!


